

TERMS AND CONDITIONS

GROW GREENER TOGETHER INNOVATION CHALLENGE 2022

When you submit your application form to participate in the Grow Greener Together Innovation Challenge 2022, you agree to the following terms and conditions (Terms and Conditions) in relation to your application for, and if selected, participation in, the final event.

1. DEFINITIONS

- “Unknown Group” is Unknown Group B.V.
- “Activities” are all the services Unknown Group provides through its website for including our events, (investment) opportunities, competitions, and more.
- “Get in the Ring” is a brand by Unknown Group.
- “Unknown Group Event” is an event that is organised by Unknown Group or under its brands like ‘Get in the Ring’.
- “Applicant” is any person and/or representative of a company that provides Unknown Group with personal and non-personal data through the Website with the purpose of participating in Unknown Group activities or any other interest in Unknown Group.
- “Startup Applicant” is any person and/or representative of a company that provides Unknown Group with personal and non-personal data through the Website with the purpose of participating in Unknown Group Activities.
- “The Visitor Applicant” is a representative of an organization that provides Unknown Group with personal and/or organizational information through the Website with the purpose of visiting a Unknown Group Event.
- “Job-Applicant” is a person interested in working at Unknown Group that provides personal data through the Unknown Group Website.
- “The Newsletter Applicant” is an individual that requests Unknown Group to provide one of the newsletters of Unknown Group about its activities.
- “Organizer” is a third party that is a licensed or contracted co-organizer of an activity of Unknown Group.
- “Partner” is a third party that is licensed or contracted by Unknown Group to collaborate on Unknown Group Activities.

- “Website” is the platform where all Applicants provide Unknown Group with details, such as but not limited to getinthering.co and its subdomains.

2. SCOPE

- 2.1. By submitting an application, the Startup Applicant agrees to enter into the selected Unknown Group Activity. Unknown Group will review the application and respond to the Startup Applicant. In case the response is positive, Unknown Group or a Partner most relevant for the specific Startup Applicant, will contact the individual Visitor Applicant to welcome him as a participant in this Unknown Group Activity.
- 2.2. By submitting an application, the Visitor Applicant agrees to visit the Unknown Group Activity that is related to the specific application. Unknown Group or a Partner most relevant for the specific Visitor Applicant, will contact the individual applicant to welcome him as a visitor of this Unknown Group Activity.
- 2.3. By submitting a newsletter application, the Newsletter Applicant agrees to Unknown Group sending newsletters and related information to the email address that the Newsletter Applicant has provided to Unknown Group.
- 2.4. By submitting a job application the Job Applicant will be contacted about the job selection process of Unknown Group. Personal information will be deleted four (4) weeks after the selection process ended, unless it is agreed between the Job Applicant and Unknown Group that Unknown Group can keep personal information for the period of one (1) year.
- 2.5. By submitting any other form the Applicant can be contacted for the specific request of the applicant.

3. COSTS

- 3.1. For Visitor Applicants and Startup Applicants there can be costs involved in signing up to participate in an Unknown Group Activity. This can be a ticket price for example. Each Activity will have its own offer and ticketing policies varying per Activity.

4. CONTENT

- 4.1. Website visitors and/or Applicants shall not reproduce any content or services, offered on the Website, for external sources without the correct reference to Unknown Group.
- 4.2. Website visitors and/or Applicants shall not commercially use any content or services offered on the Website or in newsletters for any purpose without the prior written consent of Unknown Group.
- 4.3. Unknown Group is entitled to remove any illegal or prohibited data and/or information from the Website without prior notice to the Applicant.
- 4.4. Unknown Group is not responsible for any confidential information shared by Applicants on the Website. Applicants must not include any information that the Applicant does not wish to be shared with others.

5. CONTACT WITH UNKNOWN GROUP & ORGANIZERS

- 5.1. Unknown Group organizes Activities each run by Organizers that are licensed or contracted by Unknown Group. In case an Applicant enters into an agreement directly with an Organizer, they will be jointly responsible for the execution and/or fulfillment of agreements in which they enter with one another. Unknown Group can and shall not be held accountable for any obligations resulting from these agreements and/or damages inflicted as a result of this mutual commitment.
- 5.2. The Startup Applicant is responsible for the execution and/or fulfillment of direct agreements with Partners of Unknown Group or other third parties. Unknown Group cannot be held accountable for any obligation resulting from these agreements and/or damages inflicted as a result of this relationship.
- 5.3. Unknown Group, its Organizers, and/or any of its Partners can offer Startup Applicants products and services during Unknown Group Activities. It is for the Applicants to decide whether they would like to make use of these products and services or not. These products and services are not related to the Unknown Group Activity.
- 5.4. By applying to an Unknown Group Event, Opportunity or other Activity the Startup Applicant accepts that they can be actively connected to opportunities by Unknown Group.

6. APPLICATION PROCESS

- 6.1.** By submitting an application, the Applicant consents to enter into an agreement to use the services of Unknown Group, including the use of the Website.
- 6.2.** The Applicant guarantees that the information provided to Unknown Group is true and not misleading and does not use pseudonyms or nicknames.
- 6.3.** The Applicant commits to keep their contact information as provided to Unknown Group up to date.
- 6.4.** Unknown Group has the right to refuse an application of the Applicant or end the participation thereof in the Unknown Group Activity and/or on the Website for reasons including, but not limited to:
 - Startups in industries such as the weapon, drugs and sex industry.
 - Startups that do not meet the criteria to participate in a Unknown Group Activity as stated on the webpage of the specific Activity.
 - When the application or behaviour includes insulting content including, but not limited to: pornographic, violent or racist content.
 - When the Applicant employs any mechanisms, software or scripts to damage the Website or any other software related to Unknown Group and/or its Partners.

7. PERSONAL INFORMATION

Unknown Group is committed to protecting the personal information of the Applicant provided via the Website: getinthering.co/privacy policy. Through the Privacy Policy we explain how Unknown Group uses the information provided by the Applicant.

8. INTELLECTUAL PROPERTY

- 8.1.** We recognize that you will have concerns about protecting your intellectual property. That is why you should not submit to us any confidential information. If you cannot submit your idea without disclosing confidential information, you should contact us separately at the below mentioned email address. You should consider consulting a lawyer and/or filing a patent application before submitting your idea to us.
- 8.2.** Your submission, and the information contained in it, will be received by us only on a non-confidential basis. You agree that we will have the right to

use the information free of charge as we see fit and to disclose it to affiliates and third parties for full use and disclosure as they see fit.

- 8.3. You warrant that you have the right to disclose the information to us, that the disclosure does not breach any contract or obligation between you and a third party and that, to the best of your information, possession or use of the information by us or any of our affiliates does not misappropriate or infringe any intellectual property rights of others.
- 8.4. You indemnify us and our affiliates for any damages in connection with any claim for misappropriation or infringement resulting from our possession or use of the information submitted by you or the possession or use thereof by any of our affiliates.
- 8.5. Following your submission, we may ask you to provide further information or enter into discussions with us. At that stage, we may ask you to enter into a confidentiality agreement with us to protect our mutual interests if it is foreseen that confidential information will be disclosed. If at any time you feel you are asked to disclose confidential information and no confidentiality agreement has been entered into, you should raise this with us, prior to disclosing the confidential information. If you do not raise this with us prior to disclosure, the information will be non-confidential and we may treat it as such.
- 8.6. You agree that we may process your personal data for the purpose of assessing your submission and contacting you and that we may share the personal data with our affiliates for that same purpose.

9. GOVERNING LAW AND DISPUTE RESOLUTION

The Agreement shall be exclusively governed by, and construed in all respects in accordance with the laws of The Netherlands without regard to its conflict of laws rules. Any claims, controversies or disputes arising out of or in connection with the Agreement that cannot be settled amicably between the Parties, shall be subject to the exclusive jurisdiction of the competent court of Rotterdam, The Netherlands.
